### 2. Class of consumers that fall within this target market

The information below summarises the overall class of consumers that fall within the target market for this product, based on the product key attributes and the objectives, financial situation and needs of our members that it has been designed to meet.

This product has been designed for consumers whose likely objectives, financial situation and needs (as listed below) are aligned with the product (including the key attributes).

- This product is suitable for buyers aiming to purchase established dwelling, or intend to construct residential property, and or refinance from another approved financial institution under the Land Rent Scheme. This product is suitable for Owner Occupation purposes; and who require a mortgage loan to fulfil the desired outcome. The Land Rent Scheme is an ACT initiative is designed to increase affordable home ownership for First Home Buyers, or current home owners.

#### Product description and key attributes

The key eligibility requirements are:

- An existing, or becoming a member of the Bank
- Be a permanent resident of Australia and 18 years of age or over
- A minimum 10% deposit
- Obtain a Certificate of attendance at the information sessions at the Canberra Institute of Technology
- Demonstrated ability to make repayments

The key product attributes of this product are:

- Minimum loan amount is \$50,000
- Maximum loan amount \$500,000
- Maximum loan term 25 years
- No monthly account keeping fee
- No annual fee

**Goldrate Home Loan – Land Rent Scheme**

- Redraw facility available
- Option to split home loan into variable and fixed option
- Repayment frequency options Monthly
- LVR up to 90% available with Lender's Mortgage Insurance applicable for LVR's over 80%
- Refinance from other approved financial institutions must be a Land Rent Scheme
- Available for construction purposes

Variable rate - key attributes:

- Unlimited additional repayments
- Interest offset facility, available on Principal & Interest home loans only

Fixed rate - key attributes

- Up to \$5,000 additional repayments per fixed term

Fixed and Variable key attributes

- Customers can get the best of both worlds and get the flexibility of having both a variable or fixed loan, by splitting their loan amount

**Objectives, financial situation, and needs**

This product has been designed for individuals who:

- Buyers looking for a more affordable way to purchase a home in the Australian Capital Territory to live in. It is also available for those looking to refinance an existing home loan under the scheme with another approved financial institution for a home in the ACT that they are living in.
- Have a minimum of 10% deposit to contribute towards their purchase, accepting Lenders Mortgage Insurance will be applicable & capitalized onto the base loan amount.
- Have a deposit of 20% or greater than the purchase price/ or equity in established property when refinancing. Lenders Mortgage Insurance not applicable.
- Ability to make principal and interest repayments.
- Achieve financial goals relating to the purchase of their owner-occupied residential property, and or restructuring their current mortgage to meet their individual needs.
- Have or plan to acquire residential property for owner occupied purposes.
- Owner Occupier's planning to establish residential security for long term sustainability, and future expansion of property growth.

**Fixed Rate**

- Certainty around repayment whilst on fixed rate
- Redraw access allowed for any additional repayments made to the loan whilst on a fixed period

**Variable**

- Flexibility to make unlimited additional repayments and access the additional funds at any time
- Customers offsetting loan balance by depositing savings/ or regular transfers to account.
- Flexibility in altering/amending their investment loan at any time with minimal costs

### Consistency between target market and the product

This product is likely to be consistent with the likely objectives, financial situation and needs of the class of customers in the target market. This is based on an analysis of the key terms, features and attributes of the product and a finding that these are consistent with the identified class of customers.

This product enables Owner Occupiers to take advantage of the flexibility of the product whilst making Interest Only repayments. These options include flexible repayment options, through the choice of variable rate, fixed rate, or a split between both options.

The **Variable rate** option offers additional flexibility by allowing unlimited additional repayments to be made. This rate isn't locked in, so it is suitable for those wanting to take advantage of any rate decreases over the loan's term. This option also allows for additional cash flow, as members can redraw on any extra repayments made.

The **fixed rate** options provide certainty, as borrowers know their repayments won't change during the fixed rate term. Will not be impacted by interest rate fluctuations during the fixed term, however there is limited flexibility however as additional repayments are limited during the fixed term

### Excluded class of consumers

This product has not been designed for individuals who:

- Do not live in the ACT
- Are not Members of the Bank
- Do not meet the Bank's Credit eligibility criteria at time of application
- Seeking a home loan for investment purposes

## 3. How this product is to be distributed

### Distribution conditions

This product can only be distributed and/or in accordance with the relevant product terms and conditions as outlined in the FSG and other relevant material (as amended from time to time). This product is designed to be distributed through:

- Online through the Bank's Website
- In-store retail branch network
- Relationship Banking Team
- Direct Team & Mobile Lenders

This product should only be distributed under the following circumstances:

- An existing, or becoming a member of the Bank
- Be 18 years of age or over and demonstrated ability to make repayments
- Access the product through the appropriate distribution channels

### Adequacy of distribution conditions and restrictions

The Bank's application process has been tailored to identify the Target Market described in this TMD as part of the eligibility criteria for the product covered by this TMD, and the use of the Bank's application process would make it more likely that a product covered by this TMD will be acquired by persons in the Target Market.

## 4. Reviewing this target market determination

We will review this target market determination in accordance with the below:

<b>Initial review</b>	Within 9 months of the effective date.
